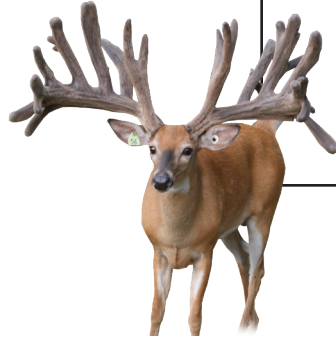

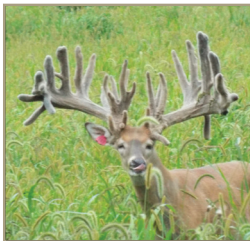

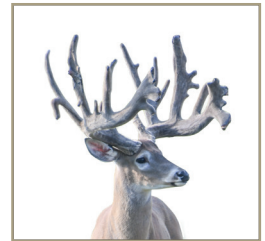

Breeder Auction Terms

Submit up to 3 lots for Breeder Auction

Juried selection of lots.

25% down day of sale, balance at pickup.

Pickup and full payment to be within 45 days.

Commission 10% (min of \$150 per lot)

No Sale Fee \$150.

Trophy Buck Terms

Commission 10% on first \$10,000, 8% \$10,001- \$20,000

6% over \$20,000. (example: 6 bucks are sold for a total of \$30,000. Total commission would be \$2400)

No Sale Fee \$100 per buck.

25% down day of sale, balance at pickup. (no exceptions)

Pickup in 30 days unless arrangements made with seller.

Seller must guarantee bucks to be healthy on trailer.

If not picked up in 60 days ownership transfers back to seller.

Auction committee reserves right to reject damaged or lopsided deer.

Withdrawn Lots

A no sale fee will be charged on any lots that are withdrawn from auction.

All Consignors must be WDFO members.

If you are a WDFO voting member there will be no \$100 participation fee. If you are not a voting member you will be charged \$100 and will be signed up for a WDFO membership

The undersigned (the sellers) agree that Buckeye Whitetail Auctions (The Auction Firm) shall sell at public auction the property described in this agreement. Sellers acknowledge that they are the owner, owners's agent or consignee of the property to be sold at auction. Sellers acknowledge the property will be sold to the highest bidder at the discretion of the auctioneer conducting the sale. "Pursuant to Ohio Code Section 70.01 (F) "Reserve Auction" means an auction in which the seller or an agent of the seller reserves the right to establish a minimum bid, the right to reject or accept any or all bids, or the right to withdraw the property at any time prior to the completion of the auction by the auctioneer. Seller hereby represents that said property is free and clear of all liens, attachments and encumbrances. Note: The failure to identify all secured creditors is fraud against the Auction Firm and criminal conversion against said creditor. "Bad checks, Unpaid items" The Auction Firm shall not be responsible for the collection of any bad checks submitted by bidders. Sellers are responsible for any debts or unpaid auction items in the event a bidder fails to submit payment for any auction item successfully bid on. "Absentee Bids" bids will be permitted via phone and internet at the auction. Advance bids may also be accepted, but shall be kept confidential by the Auction Firm. "Settlement" No interest shall accrue or be paid on money held by the Auction Firm. The Auction Firm shall pay the proceeds of any property after deducting commission and expenses within 15 days of auction unless otherwise specified. "Bidding arbitration" The parties agree that they will use their best effort to amicably receive any dispute arising out of or relating to this agreement. Any controversy, claim or dispute that cannot be so resolved shall be settled by final binding arbitration in accordance with the rules of the American Arbitration Association, and judgement upon the award rendered by the arbitrator or arbitrators may be entered into any court having jurisdiction thereof. Any such arbitration shall be conducted in Holmes County Ohio unless otherwise mutually agreed upon by both parties. Within 15 days after the commencement of the arbitration, each person shall select one person to act as arbitrator, and the two arbitrators shall select a third arbitrator within ten days of the appointment. Each party shall bear it's own costs and expenses and an equal share of the third arbitrator's expenses and the administrative fees for the arbitration.
